

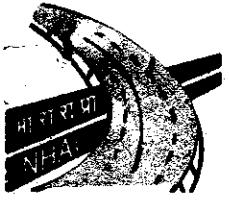

Subject: Grant of NOC for crossing of Overhead Transmission line through NHAI roads (NH-133B & NH-80 (proposed bypass)) for 2x800 MW USCTPP.

Sir,

With reference to the subject matter, kindly refer letter under ref. i.) vide which a proposal has been received by this office for Grant of NOC for crossing of 66 KV Overhead T.L. over 01 location of NH-133B & 02 locations of proposed bypass section of NH-80. Further upon scrutiny by this office and the then Project Director, Site Inspection report was prepared and proposal was forwarded with recommendation for Grant of NOC to RO, Ranchi vide this office letter dated 05.12.2019. However, RO, Ranchi returned the proposal for further calculation of License fee and Bank Guarantee vide RO letter dated 17.02.2020 as per MoRTH circular no. RW/NH-33044/29/2015/S&R (R) dated 22.11.2016. Thereafter, the proposal has been re-scrutinized wherein some observations were raised by this office and the proposal was returned to APJL for further compliance vide this office letter under ref. ii).

APJL vide its letter dated 07.10.2020 under ref. iii) has submitted its proposal with all the compliance of the raised observations. However, for verification of minimum vertical clearance criteria for Overhead crossing over NH-133B, the checklist & drawings submitted were forwarded to DPR consultant for their comments vide this office letter dated 17.10.2020. DPR consultant vide its letter dated 28.10.2020 replied that the proposal meets the minimum vertical clearance criteria as per relevant codal provisions. **However, DPR consultant further stated to ensure that the proposed crossing to comply with the clause 91 'Safety and Protective devices' and Clause 92 'Protection against lightning' of Indian Electricity Rules 1956.**

Proposal has been again scrutinized by this office and the raised observations have been found complied and the proposal is found in order. However, regarding the highlighted observation of DPR consultant, it is to bring into notice that the applicant has already submitted an undertaking that they will comply with all the terms & conditions of IRC 32 & Indian Electricity Rules' 1956.

Accordingly, the Calculation sheet for License fee has been prepared as per MoRTH circular no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and the same has been enclosed with this letter. Further, there is no provision of Bank Guarantee to be levied on overhead crossing as per the aforementioned MoRTH circular.

Hence, it is hereby recommended for Grant of NOC for Transmission line overhead crossing over NH-133B at one (01) location & Proposed Bypass of NH-80 at two (02) locations as per the proposal submitted.
