**Invitation of Public Comments**

Sub: NHAI, RO, Chennai - PIU, Krishnagiri - IDPL Pipeline Project - M/s. BPCL requested permission for laying of 18" dia Petroleum Product Pipeline along with OFC encased by 24" pipe across NH at km.53+158 in Hosur - Krishnagiri section of NH-44 (Old NH-7) by Horizontal Directional Drilling i.e. HDD method - Reg.

The proposal is regarding laying of 24" dia Petroleum Product Pipeline along with OFC across National Highway at km.53+158 in Hosur - Krishnagiri section of NH-7 (New NH-44) by Horizontal Directional Drilling i.e. HDD method at Pipeline Crossing by M/s. BPCL, Coimbatore and submitted to this office by the PD, NHAI, Krishnagiri vide letters No. NHAI/11013/ Petroleum Product/2021/PIU-K'giri/671 Dated 22.06.2021.

2. The available width of ROW at that specific location is 60.15m. The Petroleum pipe line along with OFC encased in 24" pipe is proposed to lay across the main carriageway by HDD method duly keeping the top of the casing pipe at a depth of 1.5m below the ground level.

3. M/s. BPCL, Coimbatore has furnished an undertaking to accept any claims raised by the Concessionaire if any and the same will be paid by them and furnished undertaking not to damage other utility, if damaged, then to pay the losses either to NHAI or to the concerned agency. Further, the applicant has furnished undertaking that they will adopt HDD method wherever, the available width of ROW is less than 15m.

4. As per the guidelines issued by the Ministry vide letter No.RW/NH-33044/29/2015/ S&R(R) dated 22.11.2016, the proposal submitted by M/s. BPCL, Coimbatore will be made available for 30 days seeking public comments/objections and the comments shall be furnished within 30 days from the day of closure of public objections.
