This has reference to the MoRTH, Hyderabad letter vide ref. 1st cited, wherein "In-Principle" approval has been accorded for the subject cited access permission for proposed Private Property of M/s Beeram Madhavi at Sy.no.644/E3, 644/E42/ 645/A8 etc., at Kodad Village & Mandal, Suryapet District in the State of Telangana at Km 182/047-287 (LHS) of Hyderabad-Vijayawada Section of NH-65 and further informed that if the construction is not done in one year (1 Year), the provisional approval shall be deemed to be cancelled, unless renewed by the Highway Administration beyond 6 months and up to one year from the date of issue of provisional NOC for construction of acceleration/deceleration lanes.

2. Vide this office letter ref. 2nd cited addressed to M/s Beeram Madhavi to start the above work as per approved drawings duly observing the NHAI norms/guidelines.

3. Now, M/s Beeram Madhavi vide ref. 3rd cited addressed this office (copy enclosed) stating the reasons for delay due to Parliament Election conducted in the month of May & June, 2019 and recent lock down period i.e. March to May, 2020 (COVID) and requested extension for one more year for construction of access road.

4. It is to further inform that M/s Beeram Madhavi was given access permission by MoRTH to execute service road to their Private Property duly giving relaxation as per Ministry Guidelines no. RW/NH-33023/19/99-DO III dated 16.03.2016, placing in public domain for comments & as no comments were received approval given under relaxation vide MoRTH, Hyd lr.no.RW/HYD/Misc.24/Access/RO/NH-65(9)/S.No.70/151 dated 27.05.2019. The period of one year has expired on 27.05.2020.

5. Hence, the proposal for extension is herewith recommended for a period of 6 months.

Please refer to your letter No NHA1, PIU-Hyderabad vide letter No. NHA1/PIU-
HYD/Hyd-Vij/Beeram/ Access/2018/09 dated 04.01.2019 submitting there with a proposal
on the above mentioned subject.

2. The proposal is broadly examined as per Ministry's Circular dated 24.07.2013 and it
is observed that minimum distance from intersection / median opening and take off point
of an access is at 79m against 300m. Therefore, based on justification, your
recommendation & provision of extended existing service road for length of 675m
including acceleration lane, the public comments have been invited on web portal
morth.nic.in vide this office letter No. RW/HYD/Misc.24/Access/RO/NH-
65(9)/S.No.70/949 dated 20.02.2019 as per Ministry guidelines No.RW/NH/33023/19/99-
DO.III dated 16.03.2016. However, no public Comments/ Complaints have been received
w.r.t. aforesaid deviation within specified 60 days from the date of uploading in the
website i.e. from 27.02.2019 to 27.04.2019.

3. Keeping in view of no comments received in this office & based on your
recommendation, the proposal is accepted "in-principle" subject to the following
conditions:

4. The proposal has been broadly examined based on your recommendations and the
proposal is approved "in-principle" by Highway Administration (HA)/RO, Hyderabad
subject to the following conditions and the corrections made on the proposed layout plan:

(i) The issue of final formal permission including issuance of signed license deed would
be subject to the certification by the Concerned Executive Engineer/Project
Director that the construction has been carried out in compliance with the
provisions approved by Highway Administration. Hence, it is directed to issue the
completion certificate after construction of access road as per proposed &
corrected layout plan duly endorsing a copy to this office along with fresh
license deed for issue of final permission.

(ii) The validity of the in-principle approval and the subsequent final approval shall be
governed by Para 11 of the Ministry's circular no. RW-NH-33023/19/99-DO-III
dt.24.07.2013, i.e., the Oil-company/Owner should construct the fuel
station/Private Property along with its access as per approved drawings at their
own cost within 6 months of the issue of this provisional NOC. After the
construction as per approved drawings and to the satisfaction of the Highway
Administration, the final approval will be issued within 30 days of the receipt of
communication from the applicant about the completion of construction work and
license deed will be signed by the Competent Authority (i.e. Highway
Administration). In case, the construction is not done in one year (1 year), the
provisional approval shall be deemed to be cancelled, unless renewed by the
Highway Administration.

- (iii) The fresh license deed (duly indicating chainages of NH) in two originals drawn on new stamp paper as per Ministry's standard norms and duly signed by authorized signatory may also be furnished at the time of issue of final approval. However, the Private property shall not take access before issue of final permission by the Competent Authority.
- (iv) There should be sufficient parking inside so that there is no overflow of vehicles on approach roads.
- (v) The applicant shall install all the requisite road signs as per IRC: 67 & provide road markings as per IRC: 35 in accordance with the Ministry's guidelines and to the satisfaction of the Concerned Executive Engineer/Project Director.
- (vi) The applicant shall arrange all the clearances including forest clearance required for constructing the proposed access as per approved drawing himself. The applicant shall also arrange for shifting of utilities if required at his own cost as per the direction of the concerned department.
- (vii) The existing culvert @ Km 181/949 & 182/301 shall be extended as indicated on approved layout as per direction of Concerned Executive Engineer/Project Director.

5. It is requested, that requisite fee of Rs.1,50,000/- (Rupees One lakhs fifty thousand only) under title of License Fees for access permission to private property on Bharatkosh to PAO- "002193-Regional Pay & Accounts Officer (NH), Hyderabad" and DDO-"203942- Superintending Engineer" by the licensee to the Government of India in consideration of agreement for the land for which license is issued as indicated in Para-5 of Ministry's circular no. RW-NH-33023/19/99-DO-III dated 24.07.2013 may be deposited within 30 days from the issue of this letter, failing which the "in-principle" approval now issued is deemed to be cancelled. The license deed shall be executed only after the deposit of the said fee in Central Revenue Major Head 1054 and after completion of construction as per approved drawings and to the satisfaction of the Highway Administration.

6. Notwithstanding anything in the above Para's, the in-principle approval issued shall stand cancelled under the following circumstances:

- (i) If any document/information furnished by the applicant proves to be false or if the applicant is found to have will fully suppressed any information.
- (ii) Any breach of the condition imposed by the Highway Administration or the officer authorized by the Administration on his behalf.
- (iii) If at any later stage, any dispute arises in respect of the ownership of the land on which the private property shown on layout is located or regarding the permission for change of land use.

5. This issue with the approval of the Chief Engineer-Regional Officer (MoRT&H), Hyderabad.
