
2. The above amount/expenditure is debit to the following head under Demand No.83 – Ministry of Road Transport & Highways for the year 2015-2016:-

3. It shall be ensured that the expenditure against above sanction is incurred only on the works sanctioned by the Ministry under SARDP-NE.


