
Sub: Allocation of funds to the National Highways Authority of India (NHAI) for projects under National Highways (Original)-General during the Financial Year 2021-22.

3. All other contents of the above letter shall remain the same.



2. The above expenditure is debitible to the following head under Demand No.85 - Ministry of Road Transport & Highways for the year 2021-22:-




