**Sub:** Revised allocation of funds to the State/UTs/PIUs for incurring expenditure on the National Highways(Original) [NH(O)-General] works during the financial year 2019-20 - reg.

Sir,

In continuation of this Ministry's letter of even number dated 21.01.2020, dated 10.02.2020 and after approval of Ministry of Finance dated 02.03.2020 authorising for incurring excess expenditure of ₹ 1,922.00 crore which will be adjusted through second Supplementary Demands for Grants, 2019-20, I am directed to convey the sanction of the President of India to allow ROs/RPAOs to admit expenditure against sanctioned NH(O)-General works on purely First come first served basis henceforth during financial year 2019-20 out of the total overall allocation of ₹ 23,216.08 crore under NH(O) - General for States/UTs/PIUs, subject to the condition that office of Principal CCA shall ensure that overall expenditure for NH(O) is not exceeded at any point of time as these would ensure that bills pertaining to well performing States are cleared without any delay.

2. The claims would be entertained as per revised procedure vide this Ministry's letter No.RW/G- 20011/2/2001-W&A dated 12.4.2001.

3. While entertaining the claims on the basis of allocation referred to above, it may please be ensured that:-

- (i) Expenditure is incurred only on sanctioned works on National Highways only,
- (ii) No claim is entertained for expenditure incurred on any sanctioned works in excess of the sanctioned cost beyond permissible limits,
- (iii) No expenditure is admitted on work/portion of the work where it might have been specifically advised not to incur any expenditure pending receipt/approval of certain issues/points, etc.

4. This issues with the concurrence of Finance Wing vide U.O. No.1128/TF-II dated 03.03.2020.


