Please refer to your Bid dated 26.07.2021 for execution of "Subject-Rehabilitation & Widening work for 2-lane/2-Lane with Paved Shoulder of Existing NH-80 from km 70.15 to Km 121.025 of Munger-Sultanganj- Bhagalpur section on EPC Mode in the State of Bihar", at your quoted bid price amounting to Rs 299,16,00,000.00/- {Two hundred ninty nine crore sixteen lakhs only} has been determined to be the lowest evaluated bid.

2. Ministry vide even no letter dated 29.09.2021 & 04.10.2021 has given **Letter of Acceptance (LOA) for your quoted bid price** and requested to return a duplicate of the LOA as an acknowledgement and sign the Contract Agreement within the period prescribed in Clause 1.3 of the RFP.

As per para 3.3.4 of RFP "After selection, a Letter of Acceptance (the "LOA") shall be issued in the format set forth in Appendix-VIII, in duplicate, by the Authority to the Selected Bidder and the Selected Bidder shall, within 7(seven) days of the receipt of the LOA, sign and return the duplicate copy of the LOA in acknowledgement thereof. In the event the duplicate copy of the LOA duly signed by the Selected Bidder is not received by the stipulated date, the Authority may, unless it consents to extension of time for submission. Thereof, appropriate the BID Security of such Bidder as Damages on account of failure of the Selected Bidder to acknowledge the LOA." However, you have not signed and returned the duplicate copy of the LOA in acknowledgement.

4. In view of above, you are hereby suspended for participation in the tendering process for the works of MoRTH/NHAI/NHIDCL and works under other Centrally Sponsored Schemes,
