**Invitation of Public Comments**

Sub:- Issue of access permission for construction of an approach road to the proposed Commercial building in Old Survey No.83/10 of Thenjippalam Village, Thirurangadi Taluk, Malappuram District, Kerala State at Km.270/665 (LHS) on NH-66 (Old NH-17) of Kerala State by Mr. Hamsahaji, Kondachan Parambu House, Sanmanas Road, Thirurangadi P.O, Malappuram District, Kerala-676306 and Co-applicant Mr. U.K Abdurehiman Haji, Umminikadavath, Thirurangadi, Malappuram -676102 -reg.

This office vide letter dated 26.07.2019 has accorded provisional NOC for construction of access to the above mentioned Commercial building with a condition to complete the construction as per approved drawings and furnish the completion certificate from the field authority within one year from the date of issue of provisional NOC.

2. Now, the applicant Mr. Hamsahaji, Kondachan Parambu House, Sanmanas Road, Thirurangadi P.O, Malappuram District, and Co-applicant Mr. U.K Abdurehiman Haji, Umminikadavath, Thirurangadi, Malappuram, Kerala vide letter dated 06.06.2020 addressed to this office has sought extension of time for constructing the access to the above mentioned Commercial building for another One year (i.e., up to 25.07.2021) citing the reason that delay in completion of the project due to the delay in the works related to the up gradation of the main carriageway, land acquisition and finalization of road formation levels.

3. Since, the time for completion of construction of access sought is more than one year from the date issue of provisional NOC, the proposal comes under relaxation category with regard to the non compliance of time frame for the construction of access to the above Commercial building. As per the guidelines, issued by the Ministry vide O.M. No.RW/NH-33023/19/99-DO III dated 16.03.2016, the Highway Administration will make available the relaxation application for public comments, and the comments will be invited within 60 days from the day of uploading in the format enclosed as Form 'A'.
